- Healthy Food truck vending is allowed in specific city parks, Coachella Corporate Yard, Coachella Civic Center, on private properties in the Downtown (DT-PV) and Downtown Transition (TR-PV) zoning districts, and in Date Farms.
- Fees:
 - Healthy Food Truck Initial Permit (Payable to City of Coachella): \$200.00
 - Healthy Food Truck Annual Renewal (Payable to City of Coachella): \$100.00
 - City of Coachella Business License (Payable to City of Coachella): \$184.00
