Addendum Date: October 24, 2013

Purpose: This addendum supplements, amends, and takes precedence over the original drawings

and specifications and shall be taken into account when preparing bid proposals, and shall become part of the contract documents. Bidders shall review the Addendum work and requirements in detail and incorporate any effects the Addendum may have in their

bid price.

Note: All requirements of the bidding documents remain unchanged except as cited herein.

Part 1 – Amendments to Bid Documents

Item #1 - RIGHT OF WAY POSSESSION ON PARCEL # 763-400-006

The City is in the process of obtaining possession on the above referenced parcel from the court. This parcel will not be available from the initial limited Notice-to-Proceed. Meantime, the Contractor shall prepare to work around to avoid any activities in this parcel.

The City is anticipated to receive the court-ordered possession by end of February 2014. Second Notice-to-Proceed will be issued no later than March 1, 2014.

Item #2 - COACHELLA VALLEY WATER DISTRICT (CVWD) REQUIREMENTS

It is the Contractor's sole responsibility to obtain a CVWD temporary construction encroachment permit (EP) and comply with the insurance requirements specified in the attached CVWD *Application For Construction Encroachment Permit* form.

The prime Contractor shall endorse the subcontractors on the EP application and insurance policies, otherwise, subcontractors will be required to obtain separate construction EPs. All work within the CVWD right of way will require a construction EP, except work within public utility easement.

Full compensation for the CVWD work as referenced above shall be considered as included in the prices paid for the various contract items of CVWD work. No additional allowance will be made therefor.

Item #3 - RETENTION and WITHHOLDS

Retention is revised to five percent (5%) per California Public Contracts Code – Section 7201.

The City may withhold payments for noncompliance per Caltrans Standard Specifications Section 9-1.16E.
