

## **RESOLUTION NO. 2010-41**

### **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COACHELLA, CALIFORNIA, RECITING THE FACT OF THE CONSOLIDATED PRIMARY ELECTION HELD IN SAID CITY OF COACHELLA ON THE 8<sup>th</sup> DAY OF JUNE 2010, DECLARING THE RESULT THEREOF AND SUCH OTHER MATTERS AS ARE PROVIDED BY LAW**

WHEREAS, a Consolidated Primary Election was held and conducted in the City of Coachella, County of Riverside, State of California, on Tuesday, the 8<sup>th</sup> day of June, 2010, as required by law; and

WHEREAS, notice of said election was duly and regularly given in time, form and manner as provided by law; voting precincts were properly established; election officers were appointed and in all respects said election was held and conducted and the votes cast thereat, received and canvassed and the returns made and declared in time, form and manner as requested by the provisions of the Elections Code of the State of California for the holding of elections in cities; and

WHEREAS, pursuant to Resolution No. 2010-14, passed and adopted on the 10<sup>th</sup> day of March 2010, the Registrar was thereby authorized to canvass the returns of said election; and

WHEREAS, the Registrar has canvassed the returns of said election and has certified the results to the City Council, said results are received, attached and made part hereof as "Exhibit A."

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF COACHELLA, CALIFORNIA, DOES RESOLVE AS FOLLOWS:

SECTION 1. That there were eleven (11) voting precincts established for the purpose of holding said election consisting (of consolidations) of the special elections precincts in the City of Coachella as established for the holding of County elections.

SECTION 2. That said Consolidated Primary Election was held for the purpose adopting:

1. Non-Partisan I – Coachella Utility Users Tax

SECTION 3. The whole number of votes cast in said City (except vote by mail voter ballots) was 599.

That the whole number of vote by mail ballots cast in said City was 654, making a total of votes cast in said City 1,253.

SECTION 5. The City Clerk shall enter on the records of the City Council of said City, a statement of the results of said election, showing:

1. The whole number of votes cast in the City;
2. The title of the measure item voted;
3. The number of votes given at each precinct in the City for the item voted.

SECTION 6. That the City Clerk shall certify to the passage and adoption of this resolution; shall enter the same in the book of original Resolutions of said City; and shall make a minute order of the passage and adoption thereof in the records of the proceeding of the City Council of said City, in the minutes of the meeting at which the same is passed and adopted.



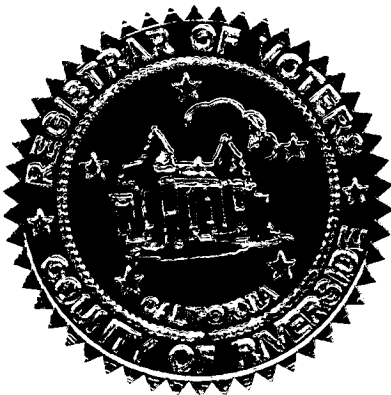
